
### Spotlights: Advocates in Elder Justice



precious to me.  
In my darkest night,  
when the moon was covered  
and I roamed through wreckage,  
a nimbus-douded voice  
directed me:  
"Live in the layers,  
not on the litter."  
Though I lack the art  
to decipher it,  
no doubt the next chapter  
in my book of transformations  
is already written.  
I am not done with my changes."
